The Regular Meeting of the Village of South Range Council was held on Thursday, November 7, 2024 at the Village of South Range Community Hall; 45 Trimountain Avenue; South Range, MI 49963

The meeting was called to order at 6:00 PM. The following council members were present: President Eakin, Trustee Marier, Trustee Harkonen, Trustee Korby, Trustee Parolini & Trustee Saaranen. ### PUBLIC COMMENT:

G. Heikkinen (Adams Twp. Supervisor) discussed the sewer rates, and removing sludge from lagoons. B. Heltunen discussed his rental on First & Globe St., and asked if the South Range Fire Dept. could fill the ice rink in his yard. President Eakin will talk to Chief Balma. J. ### STREET COMMISSIONER REPORT (Presented by D. Swetich)

Assistant Public Works Director Swetich presented the following updates: D. Swetich took the Water Test the first week of November. Hydrants were pumped out and drained, new tires on the dump truck, patched blacktop, painted the inside of the shop, and the new pump for the lift station arrived. PW has started fall discharge. Stated that the new hires are doing a wonderful job.

### PRESIDENT'S REPORT:

President Eakin: Reported he met with M. Franchi to look over progress on his property, and also met with C. Holmes (UPEA) and M. Franchi to discuss possible utility hook ups. Stated the approved driveway from the Special October 20th Meeting was completed, B. Maki is no longer

requesting a reimbursement for his flooded basement, and received a complaint of the smell of dog feces from a property on Second St. Will be contacting Scott MacInnes & Jeff Ratcliffe about coming to a Council meeting to discuss the process of a new Village Charter. President Eakin will have his annual letter ready for the regular December meeting to present to the Council for approval prior to mailing.

## CLERK REPORT:

Clerk Archambeau: Requested the approval of the annual insurance policy, and quarterly taxes were submitted on time.

## FINANCIAL REPORT:

President Eakin inquired if there were any questions or concerns regarding the October 2024 bills, if none, asked for a motion to approve payment of the bills. Bills totaling: \$201,192.62, with \$178,472.07 in old bills, and \$43,095.16 in new bills. Roll call: Ayes: President Eakin, Trustee Marier, Trustee Saaranen, & Trustee Parolini. ## BUSINESS-UNFINISHED/NEW:

Trustee Harkonen made a motion to donate \$600 to the South Range Fire Dept. for the Christmas in South Range event. Trustee Marier supported the motion. VOTE: All Ayes. MOTION CARRIED

Trustee Marier made a motion to pay the municipal insurance policy through Hannula Insurance. Trustee Harkonen supported the motion. VOTE: All Ayes. MOTION CARRIED

## 2024 Treasurer Report

The Treasurer's Report said that the 2024 property tax millage rate was 15.1127 mills (General, 12.183700; Local Street, 2.929000). The taxable value is \$15,769,749.00 which is up from last year's value of \$15,124,630.00.

Of the \$243,373.03 in total taxes, (Gen: \$192,131.83, Loc: \$46,187.53, 1% fee: \$2,381.25, Sp Assessments: \$2,672.42), \$214,355.42 was collected and \$27,815.50 were delinquent, \$1,202.11 delinquent water (last year: \$206,951.17 collected, \$16,884.54 delinquent, and \$4,132.91 delinquent water).

The pro rata distribution of the \$214,355.42 of the collected taxes is: General Fund \$169,897.63, Local Street Fund \$40,843.93, 1% Administration fee \$2,143.55 and Sp Assessments \$1,470.31.

A motion was made by Justin Marier and seconded by Tim Korby to accept the treasurer's report.

A motion was made by Justin Marier and seconded by Greg Harkonen to authorize the transfer of the \$214,355.42 in taxes collected to be made from the Agency Fund as Follows: \$169,897.63 to Local Street (100% of the amount due to Local Street) \$40,843.93 to the General Fund, and \$2,143.55 to the General Fund, 1% Collection Fee.

## PROPERTY TAX COLLECTION RESOLUTION, 2024:

Thereafter all unpaid taxes must be paid to the Houghton County Treasurer. Taxes may be paid to the Village Treasurer without penalty through September 15, 2025 Payments made to the Village Treasurer after that date will be delinquent and subject to an interest charge of 1.5% per month or partial month of delinquency and a one-time late payment fee of 4% (\$1.00 minimum)." **VOTE:**
